- Witnessed a commerical motor vehicle driving recklessly.
- Driver muscled in front of me across 6 lanes...then once I passed him and got in front of him...I guess I wasn't going fast enough and he blew his horn at me....then I proceeded to move over into the two lanes which were restricted to "NO TRUCKS OVER 6 WHEELS ALLOWED IN 2 LEFT LANES" and he muscled in front of me into the restricted lane...then when I moved over to the very far left lane, he continued to very aggressively pull the cab of his truck in front of me to "scare" me...he did that about 6 times....he was aggressive and dangerous and clearly has no business behind the wheel of a tractor/trailer....this went on from 4:15 - to 4:30 when I

finally was able to speed away from him....all this in heavy rush hour traffic. I have been driving 55 miles each way on I-85 back and forth to work for the last 15 years...and I have never seen a truck driver blatantly harass a driver like this guy did to me.....Details: This happened on March 27th between 4:15 and 4:30pm and was witnessed by many other drivers as it was rush hour traffic. It happened on I-85 beginning at exit 99 and lasting until exit 104... Truck: GMT Logistics Bloomfield, Michigan I was not sure which numbers to write down so I wrote down several: License plate : Michigan C419884 number on side of truck 5006 number on front bumper of truck 1243_ could not make out the last number as I was reading them in my review mirror and the last number was smudged or damaged...it might have been an 8 or a 3.....I expect that something will be done about this and I would like a response as to it's disposition or I will seek to take this further. These guys are driving killing machines....if two cars collide you might have a chance to survive it...if something as big as a tractor trailer hits you...your chances are not so good....Again I expect some response to this...my email is : (b)(3); (b)(7)(D)
